## Just the Facts

## Bobby Christiansen <br> President, MB-F., Inc.

As a kid growing up in the early 60 's I enjoyed watching the famous TV Police show, Dragnet on the one black \& white TV with 3 channels my family shared. I'll always remember Los Angeles police detective Sgt. Joe Friday's words during many episodes when he arrived at the scene of a crime and started asking questions, "All we want are the facts, ma'am" and "All we know are the facts, ma'am". Fast forward to 2015 and those same words have real meaning to the Sport of Pure-Bred Dogs.

I believe there are some facts that need to be told and the purpose of this article is to increase awareness. Over the years the "sanitized" AKC Delegate and Board Meeting Minutes continue to report increases in events and entries. I'm sure those numbers are accurate numbers and include every type of event AKC recognizes. However, those numbers do not report what is really happening to the core and life blood of the Sport, Conformation.

The table and graphs below were compiled from data taken from the AKC Annual Reports and tells a different and compelling story. There is an alarming and continuous downward trend in conformation competition over the past 18 years. As you can clearly see, the pie is shrinking and there are a growing number of shows chasing smaller and smaller pieces of that pie. The average All-Breed show has decreased from 1,389 dogs in 1996 down to 860 dogs in 2014. Specialty shows have decreased from an average of 85 dogs in 1996 down to 55 in 2014. Registrations are now an unpublished number and closely guarded secret.

The fact is clubs are suffering from producing longtime events once hosting 1500-2000 dogs to now holding shows with 700 dogs or less. Some clubs have cancelled shows out of economic necessity while others have ceased to exist. Point scales have dramatically changed as well.

A few examples from around the country with the requirements for a 5-point major:

I'm sure internally AKC is well aware of the issue and has tried to address the problem. Numerous initiatives such as 4-6 Month Puppy Events, Open Shows, Owner-Handled Competition, recognition of Grand Champions, Breeders of Merit, etc. have been put forth to retain exhibitors and encourage newcomers to the sport. These initiatives have all had various degrees of success and been well intended. However, instead of enticing NEW people/families into the sport, for the most part, we are "recycling" what is already there or adding new dogs belonging to existing exhibitors. Based on the facts, we are not growing. If something positive doesn't happen soon we ALL are going to be in BIG trouble.

We are in this together - the AKC, Clubs, Breeders, Exhibitors, Handlers, Judges, and Superintendents. Ben Franklin said it best when the Declaration of Independence was signed, "We must all hang together, or assuredly we shall all hang separately." If we are going to "hang together" what do we have that might help the situation?

## Witchita Kennel Club donates boots for dogs in Afghanistan

The Wichita Kennel Club received a big thank you from the United States Marine Corps for donating boots to dogs who sniff out IEDs.
"Dogs are part of the team. They're a soldier. They're actually part of the unit when they paratroop out. They do a lot," said Wichita Kennel Club Corresponding Secretary Mike Williams.

Last year, the club heard from a Marine close to a member about a need for boots to protect dogs' paws. So members decided to act.
"Those dogs that train were having their paws burned by the desert heat and there was a need for boots," Williams said. "So we checked around for suppliers here in town and we found one that supplied boots for dogs."

The dogs are trained to sniff out IEDs in Afghanistan to protect the American soldiers they are partnered with. The boots keep the dogs from burning their paws during training.
"The boots are primarily used for training purposes to protect the dogs' paws so they're in good shape when they go out and do their work," Williams said.

After hearing of the need, Williams said the club's board of directors met and decided this was a task they wanted to take on.
"We decided that would be a good project for us to do to help the soldiers over there. We consider the dogs part of the teams. Since we're a kennel club, that would be a good project for us to take on and purchase those boots and
ship them to Afghanistan."
He said the Marine close to the club helped coordinate the shipping of several pairs costing somewhere between $\$ 500$ and $\$ 1,000$. Then the deed was done until the unit decided to thank the club.
"We had heard back that they had received the boots and they had worked fine and everything was great. Then we didn't hear anything for a while and then we got this flag in the mail and this certificate from the United States Marine Corps thanking us for the boots." Williams said. "The flag
 was flown at the headquarters where this unit was at in Afghanistan and they of course lowered the flag, folded it up and sent it to us."

Williams said the club members were extremely appreciative of the thank you gift and it means a lot that the unit took the time to send it.
"It's kind of a big deal," Williams said. "I served in the military for 32 years and I'm a retired Lieutenant Colonel and I can tell you for a unit to take time to do that, show that kind of appreciation, have that certificate made, that's a big deal."

Williams said this isn't the last of the donations. He said the club plans on continuing to look out for other things needed overseas to possibly help in other ways too.
